## WAKO PANAM KICKBOXING CHAMPIONSHIP

Dear Canadian Delegate,

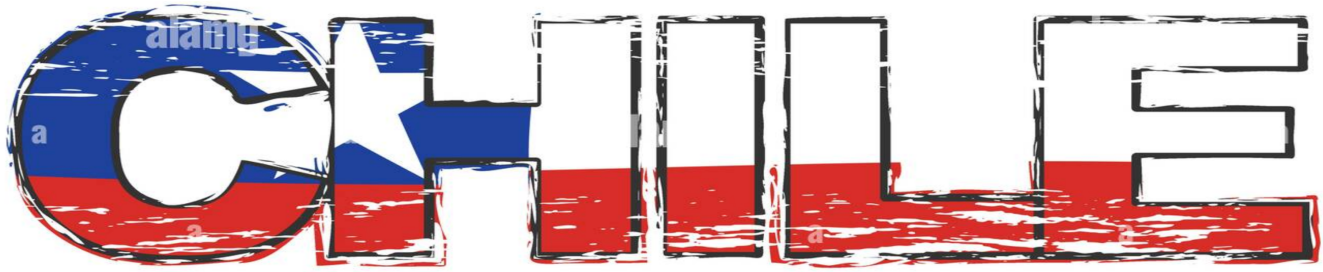
WAKO Canada is excited to be working alongside the WAKO PANAMERICAN KICKBOXING CONFEDERATION to be part of the 12<sup>th</sup> PANAM Championship. WAKO Chile was able to secure the PANAMs which will be the qualifier for the World Games in China in 2025.

The following documents provide the registration and payment information. Any forms/payments received after August 20<sup>th</sup> will have a late fee. No applications will be accepted after August 30<sup>st</sup>. Please review each page carefully and ensure you are completing the information. The following are important items to note in advance:

- WAKO Canada will be allowing all delegates to book their own flights to Chile. Flights should be booked to the 'Arturo Merino Benitez International Airport.' Transportation from the airport to the Hotel will be organized by WAKO Chile. Flights should arrive on Tuesday October 29<sup>th</sup>. Participants can arrive earlier but will be responsible for their own accommodations and internal travel. If participants arrive on Wednesday October 3<sup>rd</sup> they must arrive 12 pm, however it is highly recommended to arrive on Tuesday October 29<sup>th</sup> or earlier.
- All accommodations must be made through WAKO Canada. According to the rules of the PANAMs no private bookings are permitted for any athlete, or private coach.
- WAKO Chile is under the National Olympic Committee of Chile which will be directing all health requirements. Further details will be provided.
- VISAs are not required for Canadians however your passport must be valid for 6 months after return
- All Minors traveling must have a parent or guardian to attend the championship.
- WAKO Canada provides a GL policy for all athletes. However, all travellers are required to have their own emergency medical traveller's insurance coverage that has COVID coverage.
- All athletes/coaches must be members of a WAKO Canada Club for the 2024 or 2024/2025 membership year.
- There is one final training camp for all Ontario Athletes and Quebec Athletes (dates will be provided)
- The WORLD GAMES divisions will also be hosted in the PANAM Championship. These are as follows:  
*Point Women – 50, 60, 70 / Point Men – 63, 74, 85 – K-1 Women – 52, 60, 70 / K-1 Men – 63.5, 75, +91*

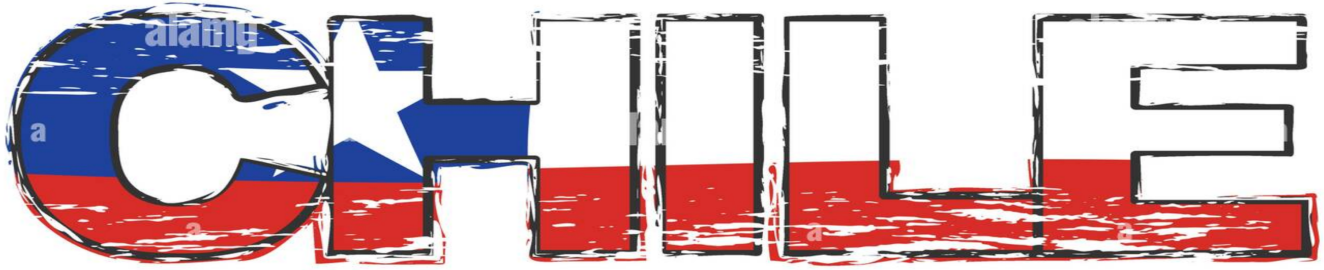

## EVENT WAIVER

I, the undersigned fully understand WAKO Code of Conduct and agree to adhere to the expectations outlined in these documents. I, the undersigned fully understand that failure to adhere to any item in these lists will result in either or all of the following: my dismissal from the team, elimination from the competition, suspension from future WAKO activities, and immediate return to the airport prior to the return date.

I, the undersigned fully understand that in consideration of membership and permission to participate in amateur kickboxing granted me or my son/daughter/ward by WAKO-Canada, I hereby release and discharge WAKO-Canada, its affiliated bodies, clubs, coaches, agents, and employees from all claims, actions, judgments and executions which the undersigned's heirs, executors, administrators, or assigns may have, or claim to have, for all personal injuries, known or unknown, and injuries to property, real or personal, caused by, or arising out of, the participation in the sports of amateur kickboxing.

I, the undersigned fully understand that the WAKO PANAM Championship event is an open competition and there is no guarantee as to the numbers of competitors that will be enrolled in any division. The officers of WAKO-Canada reserve the right to move competitors into other divisions so that they have an opportunity to compete. Each athlete has the right to not compete in the division they have been moved into – but therefore assumes the responsibility for non-participation in this event.

I, the undersigned fully understand that the officers of WAKO-Canada have made all reasonable efforts to ensure the safety and comfort of all travelers and competitors. However, I, the undersigned fully understand that traveling has inherent risks involved, including, but not limited to injury, sickness, and death due to, but not limited to, exposure to infectious diseases, change in climate, turbulent weather conditions, transportation accidents, as well as unexpected domestic crime. I am fully aware of the nature of these risks, but waive rights, claims, cause of action, etc., and heretofore, and do hereby assume all risks – both known and unexpected.

I, the undersigned fully understand that all payments are completely non-refundable if I have to withdraw from the competition for any personal reason. Should the event be cancelled for any reason beyond the control of the organizers and/or WAKO-Canada, all attempts will be made to secure refunds for all travelers, however there is no guarantee for a full or partial refund. I the undersigned, have read this Release/Waiver and understand all its terms and conditions, I execute it voluntarily and with full knowledge of its significances.



# WAKO PANAM KICKBOXING CHAMPIONSHIP

## EVENT CODE OF CONDUCT (Athletes, Coaches, Officials, Tourists)

The WAKO-Canada is committed to the highest standards of athletics, competitive ability as well as personal character development. As such it is expected that all members of the Canadian delegation will maintain a dignified and honorable presence at all times when representing Canada. In addition, WAKO-Canada is also committed to providing an environment in which all individuals are treated with respect and dignity.

All Canadian Delegation members have a responsibility to:

- Abide by WAKO Canada's Code of Conduct and Ethics.
- Refrain from any illegal behavior during the entire duration of travel.
- Athletes will not consume alcohol and/or illegal drugs at any time from the flight to the Championship to the end of the Championship. This applies to all athletes regardless of age.
- Adhere to the procedures, and expectations established by the head of the delegation.
- Consistently demonstrate the spirit of sportsmanship, leadership and ethical conduct.
- Focus comments or criticisms appropriately and avoid public criticism of athletes, other coaches, officials, organizers, or competitors.
- Refrain from any behavior that constitutes sexual harassment, where it is defined as unwelcome sexual advances or conduct of a sexual nature. This includes behavior that creates an intimidating, hostile or offensive environment.
- Demonstrate respect of individuals regardless of gender, ethnic origin, age, religion, beliefs, or economic status.
- Athletes will abstain from the use of any performance-enhancing drugs or methods.
- Respect the hotel facilities and any location visited by the delegation.

All athletes are also expected to support all members of the team during training session and the competition. All athletes are will be in their room by the 11:00pm curfew, but may be changed at the coach's discretion.

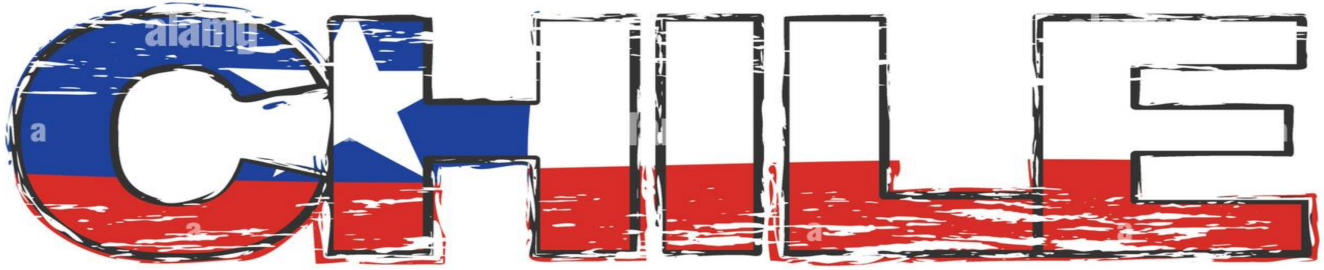
